

North Dakota University System (NDUS) – Tuition Waiver Report for Academic Year 2015-16

2015-2016 EXECUTIVE SUMMARY

The 2015-16 Tuition Waiver Report reflects waivers issued to all degree-credit students for coursework taken during the 2015-16 academic year. Continuing education or other non-degree-seeking student waivers are excluded. Student residency status is recorded in compliance with North Dakota Century Code (NDCC) 15-10-19.1. Tuition waivers are also categorized by ethnicity and institutional waiver categories. While this report evaluates waivers in a consistent manner for all eleven institutions, it is important to note that some campus-level processes may differ. Tuition waiver amounts reported in the NDUS Tuition Waiver Report are based on tuition waivers applied to what is defined as “tuition” charges. Campus processes of applying waivers may vary, with some being applied to tuition and/or fees, causing reporting differences. Certain programs may have fees bundled into tuition, resulting in the appearance of higher average tuition paid.

During the 2015-16 academic year, 46,340 degree-credit students were enrolled in the North Dakota University System (NDUS). ND resident students comprised 23,828, or 51.4%, of the total. In-country non-resident students totaled 19,556, or 42.2%, while international students were 2,956, or 6.4%. Approximately 15.2% (7,048) of the 46,340 degree-credit students enrolled in the NDUS in 2015-16 received a full or partial tuition waiver, which is a slight increase from the 2014-15 rate of 14.9 percent. Of the degree-credits students, 84.8% did not receive a tuition waiver.

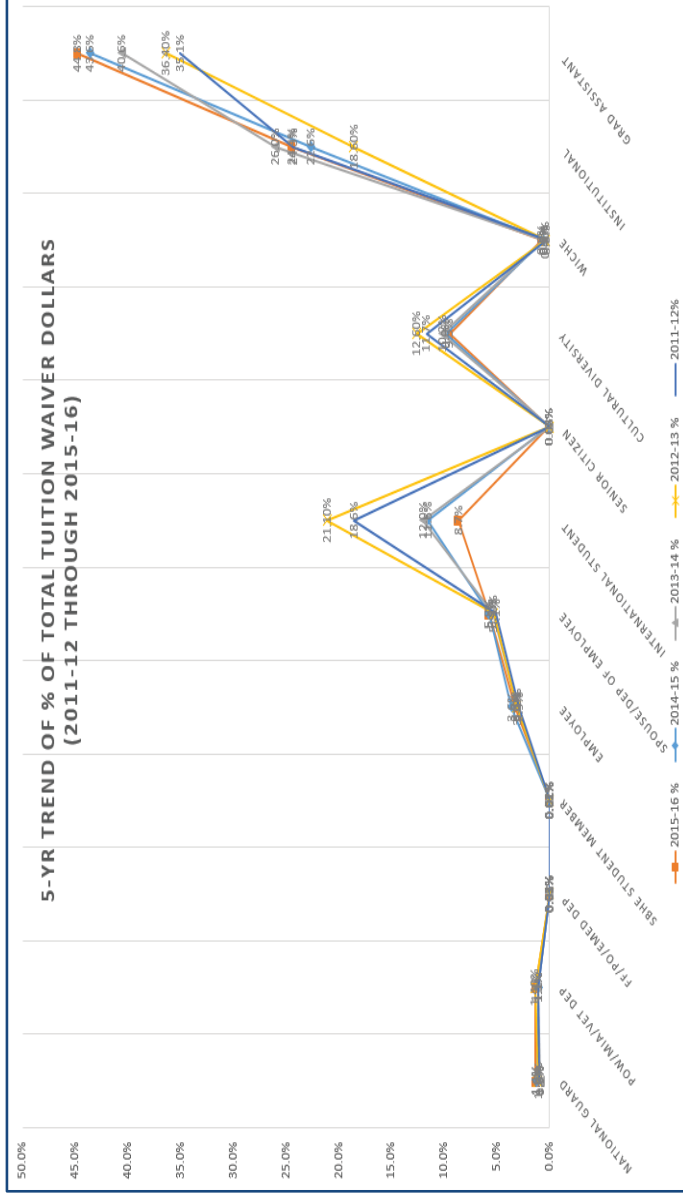
Tuition waivers totaled \$30.9 million in 2015-16. During the same time period, these students paid campuses more than \$48.8 million for tuition (\$24.7 million), housing and meal plans (\$15.8 million), and mandatory fees (\$8.3 million). At all eleven NDUS campuses, undergraduate North Dakota resident students who received a tuition waiver paid less net tuition on average than did all non-resident in-country or international students. At the four institutions that offer graduate or professional programs (MISU, NDSU, VCSU, and UND), ND residents who received a tuition waiver paid less net tuition on average than all non-resident students and international students. Additionally, at a majority of the institutions, when considering all ND residents, both with and without a waiver, the ND resident students still paid less than the non-resident students.

Over the past 8 years, NDUS campuses have made significant reductions in international waivers while remaining fairly constant with ND resident and in-country non-resident waivers. Students can receive a full tuition waiver or a partial waiver ranging between 1 and 99%. Of the 7,048 (15.2%) students receiving waivers in 2015-16:

- 1,896 (4.1%) received full waivers, while 5,152 (11.1%) received partial waivers
- Approximately 2/3 of the students receiving partial waivers received a tuition waiver of less than 50%. The remaining 1/3 received waivers of 50% or more.
- ND resident students received 45.4% of full tuition waivers and 52.1% of partial tuition waivers.
- In-country non-resident students received 23.0% of full tuition waivers and 35.7% of partial tuition waivers.
- International students received 31.6% of full tuition waivers and 12.1% of partial tuition waivers.

Tuition waivers fall into three categories: state mandated; State Board of Higher Education (SBHE) required; and institutional discretion. The majority of tuition waiver categories saw little change from the prior year. International waivers decreased by 2.9%. Institutional waivers and graduate assistant waiver both showed a slight increase at 1.8% and 1.2% respectively.

- State Mandated:** ND Century Code requires full tuition waivers for dependents of POW/MIA Veterans who were killed in action, died of service-related causes, were prisoners of war, have a 100% service-connected disability, or who were declared missing in action. A full tuition waiver is also provided to dependents of emergency personnel killed in the line of duty. National Guard members receive a 25% tuition waiver, while state funding provided to the Adjutant General covers the remainder of the National Guard member's tuition. These state-mandated waivers accounted for 2.7% of the total waivers in 2015/16, which is down from 5.1% in the previous year.
- SBHE Required:** SBHE policy requires limited tuition waivers for benefited employees, 100% waiver for the SBHE student member, and senior citizen waivers. Effective May 1, 2016, SBHE policy requires 50% spouse and dependent waivers. SBHE policy waivers accounted for 3.3% of total waivers in 2015/16. This was also down from the previous year's rate of 7.9%.
- Institution Discretion:** Institutions may offer tuition waivers for graduate assistants (teaching and research), international students, cultural diversity, WICHE and other institutional needs. Total institutional waivers accounted for 94.0% (\$29.6 million) of total waivers in 2015/16, relatively unchanged from the previous year, which was at 94.1% (\$14.1 million), institutional (\$7.7 million), and cultural diversity (\$3.0 million) are the three largest categories of discretionary waivers. Of the total cultural diversity waiver dollars awarded in 2015/16, 35.3% were provided to Native American students.

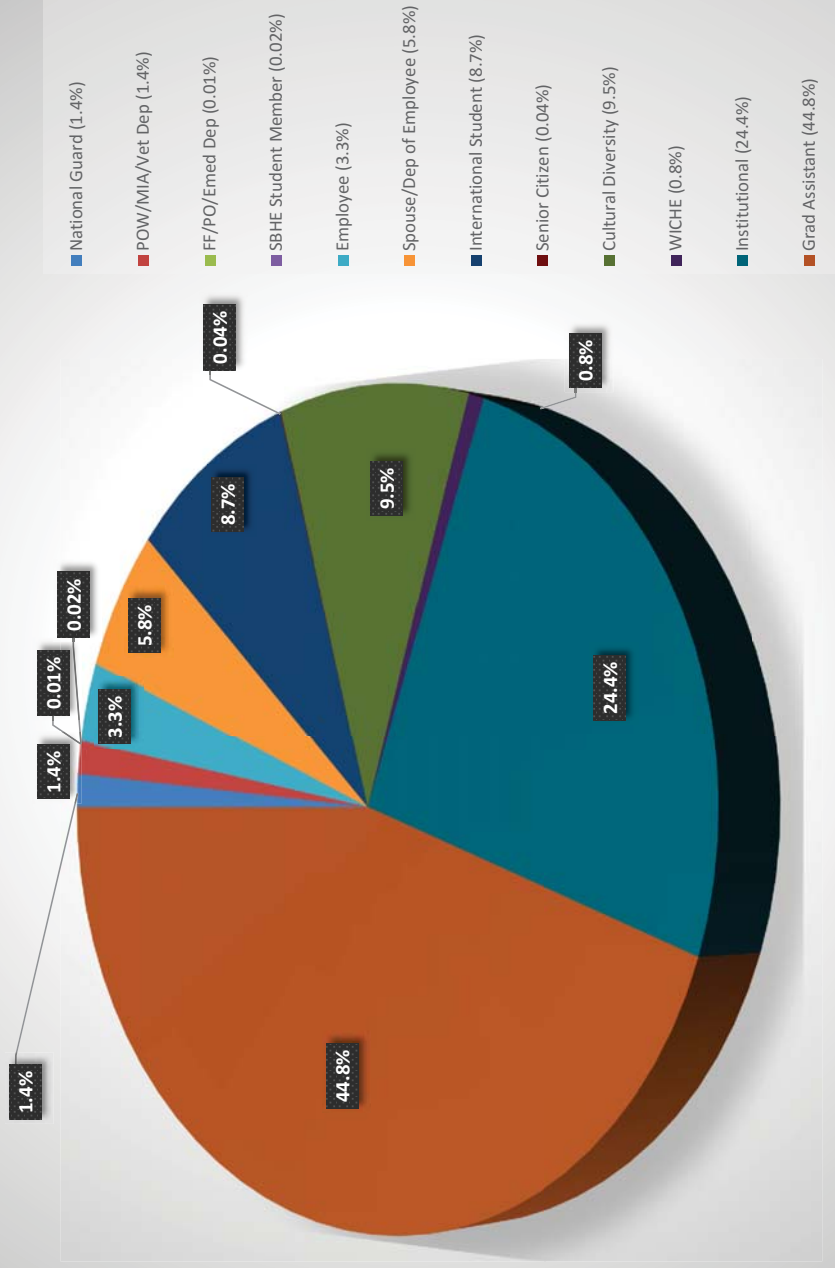


Historical Look at Waiver Expenditures

When considering the 2015-16 percentage of total dollars waived by waiver category, it is noteworthy to point out that the pattern of waiver application is relatively stable from year to year.

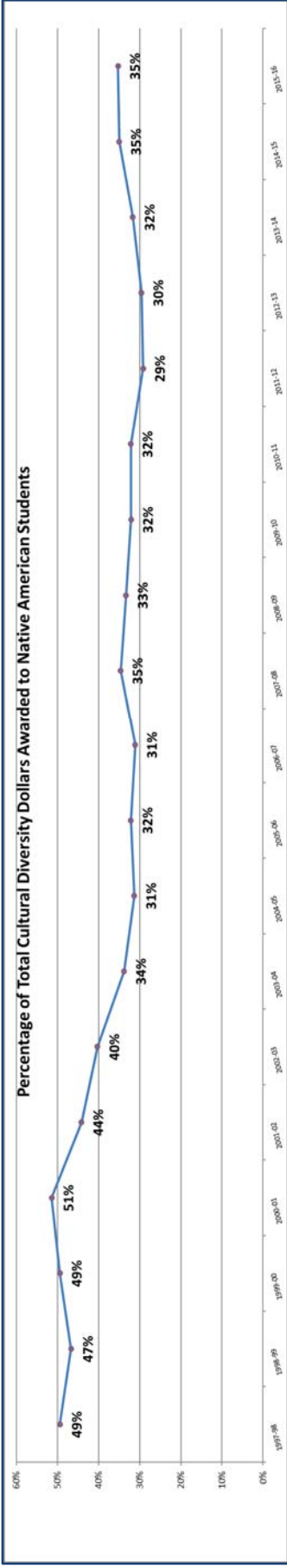
This chart shows the tuition waiver percentages by category for the past 5 years. When overlaid from year to year, a consistent pattern of expenditure is revealed.

2015-16 Tuition Waivers by Category

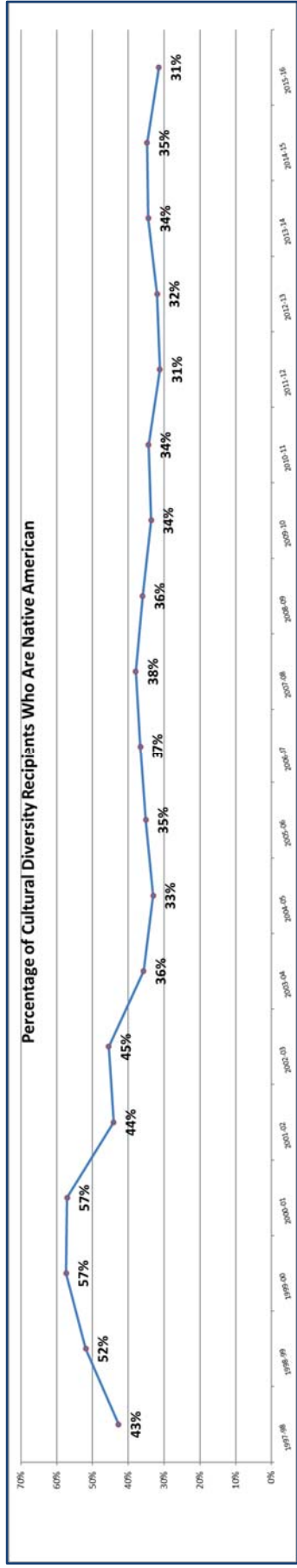


A Consistent Theme

- ✓ The majority of waiver categories saw little change from the prior year.
- ✓ International waivers decreased by 2.9%.
- ✓ Institutional waivers and graduate assistant waiver both showed a slight increase at 1.8% and 1.2% respectively.



The NDUS institutions offer full or partial waivers to some students from different cultures and origins in order to encourage diversity on campus. Cultural diversity is defined as any individual of different cultural, racial or ethnic heritage, or persons with disabilities, and/or life experiences. In 2015-16 approximately 9.5% of the waiver dollars were made to culturally diverse students. Since 2005-06, the average number of Native American students making up the cultural diversity waiver category is 31%, with total average dollars to Native American students at 35%.

¹ Student total counts are unduplicated and include students who receive more than one type of waiver.

² The tuition and tuition waivers reported are for students seeking degree-credit, with the exception of chart 7 and chart 8. Since charts 7 and 8 include all campus waivers, the amounts for the campus total may vary slightly from those reported in the remainder of the report. Amounts are rounded to the nearest dollar. Headcount enrollments used for calculation purposes are based on end of term data for all students charged tuition and mandatory fees in the academic year (1610 - 1640). These numbers will not align with official beginning of term enrollment, however, neither will cause a substantial change in the reported data.

While the previous charts provide data in great detail by school, the following trend line provides a representation of how waivers have trended over the years with shifts in enrollment. Chart 2 details waivers by enrollment category (ND resident, In-country non-resident, International). The following trend line compares the number of waivers provided by enrollment category to the total enrollment in each of these categories. Since 2008-09, the NDUS has made significant strides in reducing the tuition waivers to international students while maintaining relatively constant waiver levels for ND and in-country non-resident students.

NDUS % of Students Receiving Waiver Compared to Total Enrollment - by Category

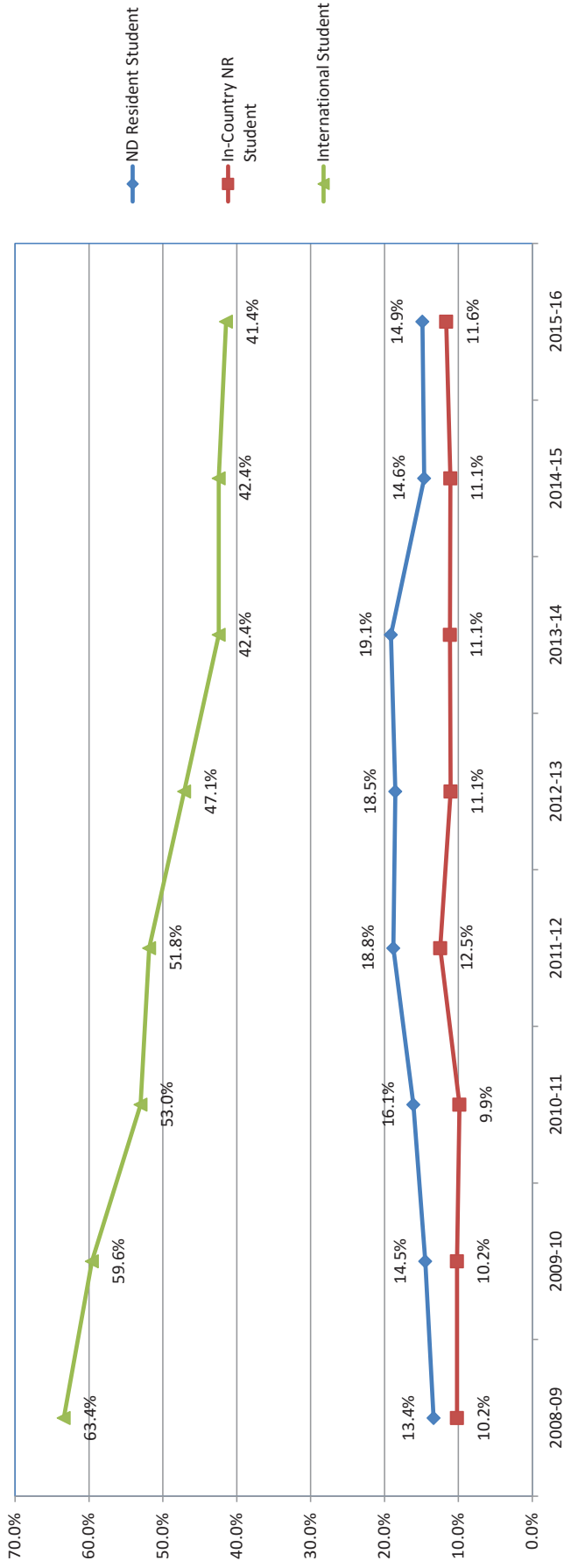
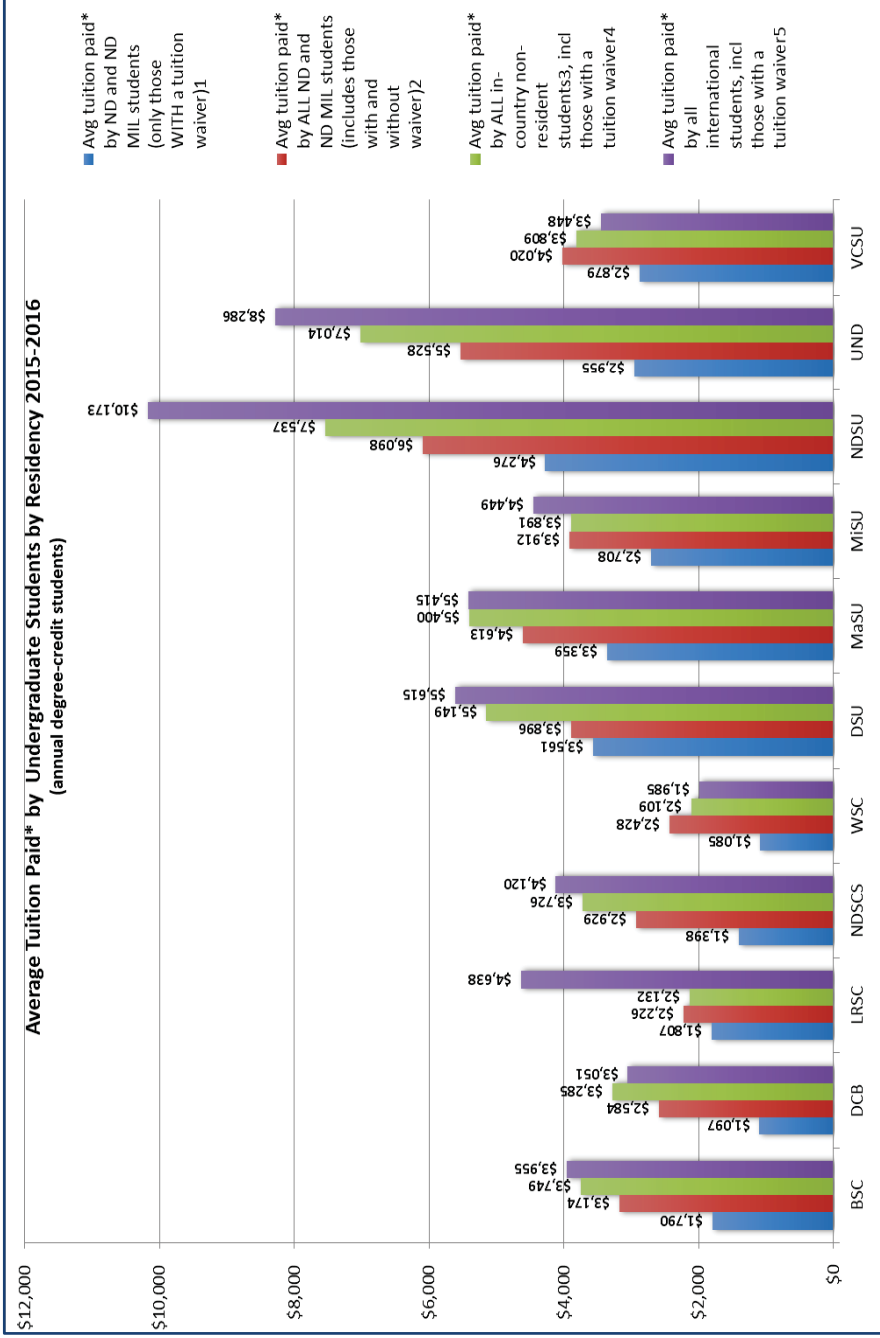

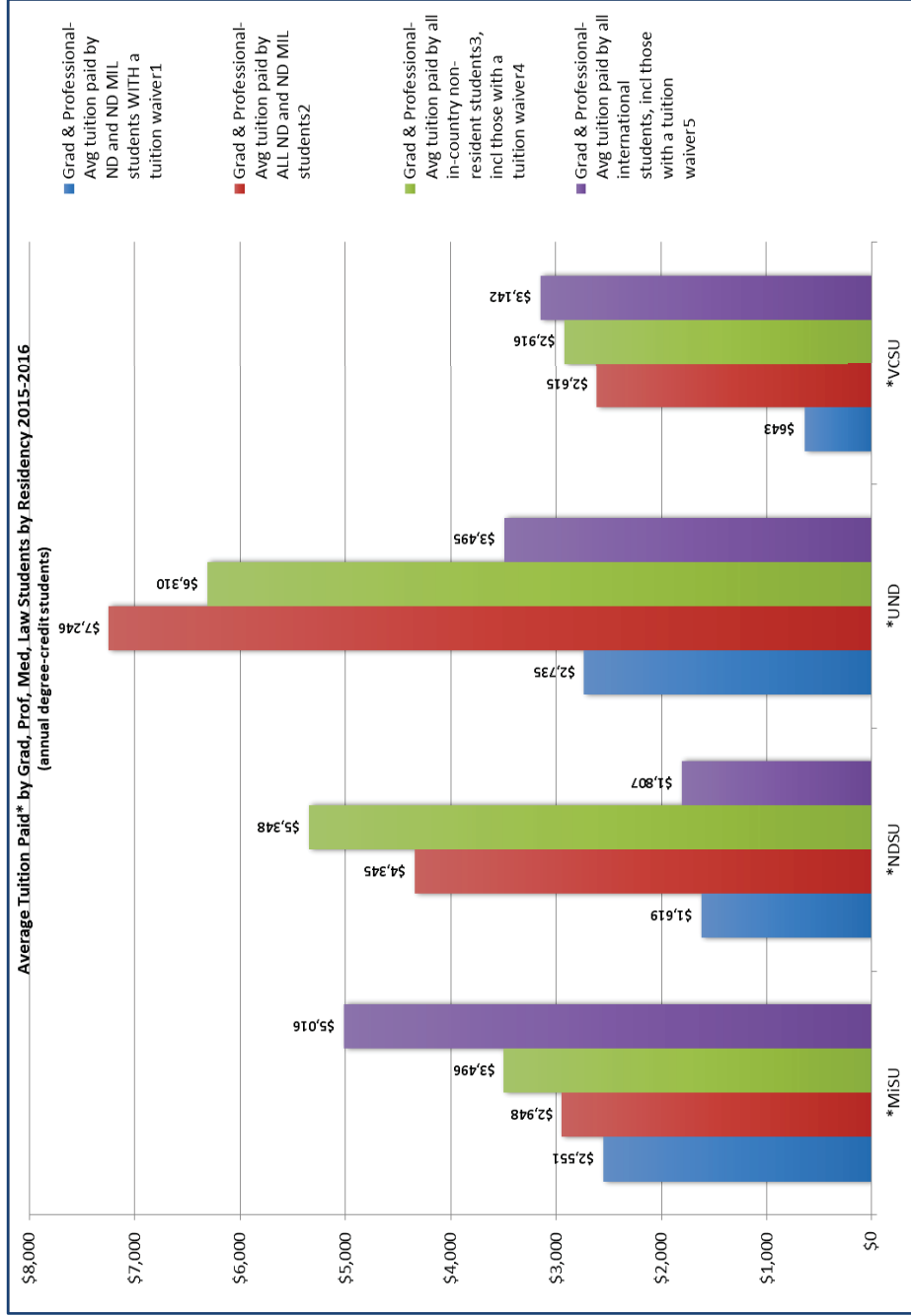
