#### North Dakota State Board of Higher Education Academic and Student Affairs Committee February 18, 2020, Meeting Minutes

The State Board of Higher Education's Academic and Student Affairs Committee met via conference call on Tuesday, February 18, 2020, at 11:00 a.m. CT. The call originated on the 10<sup>th</sup> floor of the State Capitol, NDUS Conference Room, 600 E. Boulevard Ave., Bismarck, ND.

Chair Louters called the meeting to order at 11:05 a.m. CT.

#### 1. Agenda

Dschaak moved to approve the agenda.

Dschaak and Louters voted yes.

#### 2. Meeting Minutes

Dschaak moved to approve the January 21, 2020, meeting minutes.

#### 3. NDSU Tenure

Ms. Johnson reviewed the proposal of two tenure requests from NDSU.

Dschaak moved to recommend approval.

Dschaak and Louters voted yes.

#### 4. Policy 515 ND Student Association

Mr. Olson reviewed the proposed new <u>policy 515</u>, ND Student Association. He has worked closely with Ms. Johnson and Mr. Dschaak on the drafting the policy. They attended a ND Student Association meeting to further discuss, along with more recent follow-up conversations with Mr. Dschaak to ensure it meets the needs of NDSA. The proposed policy establishes the North Dakota Student Association as a functionally independent entity, with limited SBHE oversight over the NDSA fee and facilitates compliance with laws and regulations. It also covers the required areas to permit NDSA delegates to access state fleet vehicles and other NDUS shared services during the pendency of these issues. In effect, the policy establishes a way for the NDSA to continue functioning as they always have. As written, the policy will expire at the end of this fiscal biennium, July 1, 2021.

Mr. Dschaak expressed appreciation for the time and attention that Ms. Johnson and Mr. Olson has given the NDSA. He indicated that ten out of eleven campus representatives participated in a nonbinding vote at a past meeting and another meeting will be taking place this week for ratification of approval from the NDSA to the SBHE.

Mr. Dschaak moved to recommend approval of waiving 1st reading, approving 2nd, and final adoption of policy 515.

Dschaak and Louters voted yes.

Ms. Johnson stated <u>policy 605.3</u>, Nonrenewal, Termination or Dismissal of Faculty, is for informational purposes only to remind committee members of the sunset clause.

#### 14. Student Behavioral Health Update

Mr. Dschaak indicated the system office has a working group, including campus representatives and students to gather feedback on the needs to provide adequate counseling for students on campus. Specifically, how and what services to provide and the funding necessary to meet those needs. Ms. Fitzsimmons will also be conducting a system wide survey to collect information and to gather the budget needs of each campus as they relate to student behavioral health. Continuing the telemedicine program that is currently in place is an option; however, face-to-face counseling is the preferred method by many students. The system office will be working with Ms. Pam Sagness from the North Dakota Department of Human Services to highlight areas of overlap and to identify areas that would need more attention, staffing, and/or funding. From there, the system office will determine what needs/request merit legislative action. Mr. Dschaak and the system office will continue to work with the committee on possibly having student behavioral health as a topic at the June SBHE meeting for discussion.

## 15. Instructional Consistency/Flood Concerns Information

Ms. Lisa Johnson informed the committee that discussions regarding possible campus flooding have begun and she will keep the committee informed as spring thaw approaches.

## 16. Update on Open Educational Resources (OER) Conference

Ms. Johnson stated there will be an <u>Open Educational Resources (OER) Conference</u> in Fargo on March 6<sup>th</sup>.
