## 1. Agenda

Morton moved, Neset seconded, to approve the agenda.

Morton, Neset, and Ryan voted yes.

# 2. Minutes 1-24-20

Neset moved, Morton seconded, to approve the minutes. Morton, Neset, and Ryan voted yes.

## 3. Legacy Fund Research Proposal Update

Chair Ryan opened the discussion on the updated Legacy Fund Research Proposal, as edited by Valley Prosperity Partnership. Committee members discussed the changing landscape since the committee last met, however gave general consensus to move forward with a sub-committee with membership

comprising of NDUS VPP representatives to review the document and provide the SBHE Research Committee with recommendations.

Morton moved, Neset seconded, to add Dr. John Mihelich, Dr. Jane Schuh, Chair Ryan, and President Bresciani as the NDUS representatives to the sub-committee.

Morton, Neset, and Ryan voted yes.

Chair Ryan made a note that the sub-committee is advisory only.

#### 4. Research Metrics Update

Dr. Mihelich and Dr. Schuh briefed the committee on potential forward looking research metrics that can be used in the near future to gauge progress of the research enterprise. Each metric is to be used according to the current need and focus of the research initiatives at the time of review. For most metrics, information can be broken down by discipline or college, and apply to primarily undergraduate institutions (PUI) as well.

Dr. DeMuth volunteered to begin surveying the research activity of the PUIs.

#### 5. UND, NDSU and ND Commerce Commercialization/IP Update

Dr. Mihelich and Dr. Schuh updated the committee on the status of the Commercialization/IP initiative. Due to the COVID-19 pandemic, Cortnee has been assigned to other duties at the Department of Commerce, and is unable to work on the initiative at this time. There is hope that work will continue, but it is uncertain at this time.

## 6. Research Faculty Shortage

The Chancellor, Dr. Mihelich and Dr. Schuh opened the discussion on the continuing issue of attracting research faculty in the midst of recurring budget cuts in a cyclical economic environment. Dr. Mihelich and Dr. Schuh will begin to develop strategies for attracting and retaining faculty, then present their findings to the committee in the near future.

Chancellor Hagerott proposed the idea of discussing human capital initiatives with the Governor at the next strategy session, in which funding could come from the General Fund.

## 7. COVID-19 Implications/Plan

Chancellor Hagerott provided an update on COVID-19 impacts to both NDUS and SBHE Research Committee initiatives.

Chair Ryan adjourned the meeting at 4:15p.m. CT.
