## 3. MiSU Research Overview/Presentation

Dr. Heidi Super and Dr. Bryan Schmidt gave presentations on <u>MiSU Research projects</u>. The presentation covered a wide variety of research components, including, but not limited to the following:

## 4. NDSU Development, Production and Evaluation of Cold Hardy Grapes

Dr. Shana Forster, Center Director NDSU North Central Research Extension Center (REC), Minot and Dr. Rod Ballinger, Co-Founder, Bear Creek Winery, Fargo, President, WAND, presented on development, production and evaluation of <u>Cold Hardy Grapes</u>. They reviewed the vision of the ND grape and wine industry. The industry ability to expand, improve the quality of life for North Dakotans, increase tourism, revitalize rural communities.

After questions and answers from all presenters, Chair Ryan stated the committee requests the other campuses present during upcoming meetings to give each campus an opportunity to present research initiatives. The October agenda will include a presentation from UND and NDSU. Committee members noted that hearing from all institutions will be helpful to understand the overall research initiatives, plan, and funding options to be considered. Funding for all institutions will be vital for the state-wide initiative and be included in the proposal moving forward.

Dr. Ryan requested that President Bresciani and President Armacost work collaboratively to clarify language in the proposal regarding the funding and identify dollar amounts for the committee to consider adding into the proposal. They also requested the Chancellor work with stakeholders outside the University System for input and to include Chair Ryan and Dr. Demuth in those meetings.

Ms. Hetzler will work with CTS to post the presentations to the NDUS website and distribute presenters contact information to the committee for any follow-up inquiries.

## 5. Discussion on Research Excellence and Innovation

Dr. Ryan stated there will be further discussions and a request for input from all stake holders on research excellence and innovation prior to the Board's retreat and/or the Board's strategic planning session.
