7. **Reconvene Open Meeting** (12:50 p.m. CT.)

Neset moved, Solberg seconded, to offer the Williston State College Presidency to Dr. Bernell Hirning, beginning July 1, 2021.

8. NDSU Indoor Practice Facility Project

Ryan moved, Warford seconded, to approve <u>NDSU to proceed with the Indoor Practice Facility project</u> at an estimated cost of \$37,200,000 funded from private donations. Further authorize NDSU to name the building in honor of an anonymous donor as per SBHE policy 902.12. The donor's name and official name of the facility will be released in conjunction with full SBHE meeting on April 29th.

9. **SBARE Nomination**

Ryan moved, Warford seconded, to approve the <u>SBARE nomination</u> and appoint Mr. John Dhuyvetter to a four-year term on the State Board of Agricultural Research and Education beginning July 1, 2020, representing northwestern North Dakota.

Louters, Solberg, Mihalick, Neset, Bye, Ryan, Warford, and Hacker voted yes.

10. **Honorary Degree**

Ms. Lisa Johnson presented an honorary degree from Valley City State University.

Louters moved, Solberg seconded, to award an Honorary Degree to Mr. Mark Ertelt, from VCSU.

 - NDSCS Workforce Academy by President Richman.

The Board discussed the following:

- Last full SBHE approval was in June of 2017, presented as an NDSCS workforce academy and SBHE approval was for fundraising for a potential workforce academy without utilizing North Dakota State Universy System and/or state dollars:
 - The SBHE specifically indicated that no lease, building/construction, rent, or purchase of property is allowed without proper authority/approval and no state funds were to be used
 - Administators, staff, and/or faculty paid from state dollars have worked on the NDSCS Fargo project
- The project presented in 2017 as an NDSCS project was amended to the current proposal for the NDSCS Foundation to build and own the facility and NDSCS to lease from their foundation;
 - o SBHE fiduciary duties
 - The success of current workforce academies, such as Bismarck State College, that are tthrough the North Dakota K-12 system and that NDSCS's proposal would be taking a different path
 - Past projects involving the institution foundations that resulted in the SBHE/legislative assistance that involved tax payer dollars
- Authority outside of fundraising was not given by the tSBHE and/or legislation
- NDSCS approval process not meeting SBHE expectations
- Pledges collected vs. outstanding
- The CFI report
- Ground breaking ceremony to be postponed
- Clarity of Legal and financial relationship between the institutions and foundations

President Richman responded:

- The proposal in June of 2017 was a concept
- The NDSCS Fargo workforce academy written in his goals
- The current status is:
 - o Draft lease agreement between NDSCS and NDSCS foundation
 - o Draft Operation agreement between NDSCS and four school districts
 - NDSCS Foundation will own the new building/facility
 - o Twenty million dollar project
 - o Land is purchased at 64th Avenue South, Fargo, ND
 - o NDSCS staff have been used to assist in the Fargo project
 - o EAPC is the Arcitect
 - o Interior design is in the final stage
 - o May 6th is the opening for bids
 - Final lease agreement dollar amounts will be provided at the May SBHE meeting

After discussion, members Mihalick and Ryan requested the SBHE re-direct the project back to the SBHE Budget and Finance Committee for further discussion. The SBHE members agreed and will re-visit at a future meeting.
