July 22, 2021, Special Meeting Minutes

1. BSC Gateway to Science Lease Amendment

Ms. Rebecca Collins provided information on the proposal for the <u>BSC Gateway to</u> Science Lease Amendment.

Warford moved, Bye seconded, to approve the proposed lease amendment.

Warford, Lian, Bye, Volk, Louters, and Ryan voted yes.

2. UND SMHS Compensation & Health Insurance Transfer

Mr. Jed Shivers and Ms. Dolan presented the request for <u>UND SMHS Compensation & Health Insurance Transfer.</u>

Louters moved, Bye seconded, to approve the UND SMHS Compensation & Health Insurance Transfer.

Louters, Bye, Warford, Lian, Volk and Ryan voted yes.

3. UND P3 Housing Project

President Armacost and Mr. Jed Shivers presented the proposed <u>UND P3 Housing Project</u>. The Board discussed the various components of the project, such as, a 30 year vs. 40 year financing, Risk Management/liabilities and projected housing needs/occupancy.

Warford moved, Bye seconded, to approve the UND P3 Housing Project, specifically the resolution attached to the item, page 38; further, authorize the Chancellor and UND President to execute any further documents needed.

Volk, Louters, Warford, Lian, Bye and Ryan voted yes.

4. UND Raze 29 Apartments and 6 Residence Halls

Mr. Jed Shivers and Mr. Mike Piepers presented the request to the <u>UND Raze 29</u> Apartments and 6 Residence Halls.

Chair Ryan requested that UND reach out and confirm there are no concerns/issues with previous donors and/or family names associated with the project. UND representatives stated those types of conversations are occurring and will continue.

Louters moved, Bye seconded, to approve UND Raze 29 Apartments and 6 Residence Halls, contingent on compliance with the State Historical Society and SBHE policies 903 and 902.12.

Lian, Volk, Louters, Bye, Warford, and Ryan voted yes.

5. NDSU Presidential Search

Chancellor Hagerott provided an update on the status for the NDSU Presidential Search.

Bye moved, Warford seconded, to authorize Chancellor Mark Hagerott, in consultation with North Dakota State University and SBHE Leadership, to hire a consultant to assist with the search for the next president of NDSU, and to propose a search committee. And further, to appoint Dr. Jill Louters and Dr. Greg Lardy as co-chairs to serve on the search committee for the next president of NDSU.

Louters, Lian, Volk, Bye, Warford, and Ryan voted yes.

Mr. Volk moved to include himself (SBHE Member Volk) as a member of the NDSU Presidential search.

Motion failed for lack of a second.

6. The Strategic Plan Components Recommended for Approval

Mr. Jerry Rostad reviewed the goals to approve, along with others that will continue to be reviewed and worked through.

Bye moved, Warford seconded, to approve identified goals ready for approval.

Chair Ryan announced that NDSCS President Richman has submitted his resignation, effective December 2021. Chair Ryan stated the Board did ask President Richman if he would consider an extension; President Richman declined, his resignation would be effective December 17, 2021.

Bye moved, Louters seconded, to adjourn the meeting at 9:50 a.m. CT.
