# 5. Update on Legislative Interim Higher Education meeting

Ms. Lisa Johnson provided an update on draft bills discussed at the September 7<sup>th</sup> Interim Legislative Higher Education Committee meeting. She explained the bills are still being reviewed and/or modified and she will continue to provide updates at future meeting. The following are some components that were discussed:

- Teacher education/teacher shortage
- Resurrecting the teacher loan forgiveness program
- Various changes to existing scholarships
- Accelerate academic programs
- Increase the state's needs-based grant award
- Increase funding for the Challenge Grant program to \$24 million to support institutions to expand educational programs
- Funding for students with some college and/no degree in in-demand fields/the most severe shortages in the state.

Mr. Black provided a brief update on the September 19th Joint Boards meetings. He stated there was a robust discussion regarding North Dakota teacher shortage, especially severe in the rural communities. He commended an apprenticeship approach taken by some colleges to help address the current teacher shortage.
