#### 2. Approval of Agenda

4. Approval of updated ND Higher Education Challenge Fund rules of Operation and Procedures

NDUS staff reviewed NDCC 15-10-48 through 15-10-53 and reached out to the Attorney General's office for additional review, to ensure the updates from the latest legislative session were in alignment with the Rules of Operation, as requested by the committee. The pooled funding section was updated based on recent legislation to display the different pools and how each campus can access them. The rules currently state that applications are to be considered in chronological order, which is in alignment with century code, and was how the applications were provided at the January 2023 meeting. The committee ultimately makes the determination on how the funding is distributed and has the authority to define the process for inclusion in the Rules of Operation.

The committee discussed restructuring how pooled funds are accessed and distributed, an option for institutions to request an extension rather than pooling unused funds, and whether UND School of Medicine falls in the same tier as UND and NDSU. Member Volk requested the system office investigate options to improve the pooled fund tiers and process, and to also seek an Attorney General's opinion regarding the language that references the School of Medicine. Chair Beehler asked that the system office investigate some of the changes and recommendations identified for the committee's March meeting, the system office agreed.

Martinson moved, Burgum seconded, to approve the updates to the rules and operations, as presented.

Approved by consensus.

NDUS Staff explained that at the October 4<sup>th</sup> meeting, the Chair had asked the System Office to develop an informational template that could be used by each campus to provide the information that is normally provided by the campus's foundation agreements. Currently, the required documentation is extensive and requires a lot of administrative work to redact and copy. The System office developed a template, reviewed it with Chair Beehler, and then provided it to each campus foundation to review and have an opportunity to provide their feedback. The final template was emailed to the committee for review/feedback and final approval. The committee approved via email and the support template is now approved for use. The scope and fund applications were updated to remove the budget section information and a new summary of applications template was created for each campus. The new templates provide consistency in the way the information is being provided to the committee. The attached documents were approved by the committee via email on October 19, 2023.
