President Jenson provided a <u>PowerPoint presentation on the background and context</u> of BSC's request to expand its degree offerings to Bachelor of Science degrees. He explained his strategic master plan as it relates to enrollment, including but not limited to the following:

- Addressing workforce needs.
- Programming for a new Polytechnic facility.
- Creating new degrees in short-term stackable credentials.
- Red tape reduction.
- Implementation of a unit cost model.

The committee members discussed various components that need to be considered if BSC and/or any other NDUS institution requests approval for academic programs that are outside the authority of SBHE Policy 409 (Degrees Offered) and Policy 420 (Accreditation), or any other policy that regulates institutional programs. After a thorough discussion, Chancellor Hagerott offered to move the discussion to the ENVISION 2035 process. He explained that expanded scope academic programming requests should be a system-wide discussion, rather than an individual request, as other NDUS institutions may have similar requests. The committee agreed, no further action took place.
