Billier moved, Black seconded, to approve NDSU's program termination request, item 5a(i), as presented.

Billier, Black, Hanson, and Warford voted yes. Motion passed 4 – 0.

6. **Policy 603.1 Harassment and Discrimination**

- a. Deletion of Policy 520, Title IX – Sexual Harassment

Mr. Chris Pieske proposed changes to Policy 603.1 Harassment and Discrimination and the deletion of Policy 520 Title IX sexual harassment. These changes were based on the new Federal Regulations on Title IX.

Billier moved, Black seconded, to recommend approval to delete Policy 520 and to amend [Policy 603.1](#), Harassment and Discrimination, as presented.

Billier, Black, Hanson, and Warford voted yes. Motion passed 4 – 0.

7. **ASAC Work Group Report**

- a. Three-year Degrees
- b. Accelerated or Combined Master's Degrees

Vice Chancellor Johnson summarized the [main findings and recommendations](#) of each work group. The members and other participants shared their comments and feedback.

8. **Academic Tenure**

At the April 25 meeting, the SBHE directed the committee to review the process/procedures of tenure at the NDUS two-year institutions. VC Lisa Johnson started the discussion with the [compilation of feedback](#) from the two-year institutions. She noted that Bismarck State College (BSC) took a different approach than the other institutions and surveyed the faculty.

After discussion, Chair Warford provided options for next steps:

- a. ASAC Committee continue to review.
- b. Refer comments/concerns to the Ad Hoc Committee on Tenure for incorporation into their Tenure Report.
- c. Forward it directly to the full Board.

Member Black had a meeting conflict and had to depart the committee meeting; but requested assurance that if the committee's decision is option b or c, there will be dedicated time at a full Board meeting to discuss. Member Black also requested that the Ad Hoc Committee address how tenure protects academic freedom at two-year institutions and that any final reports be shared with all Board members prior to meeting.

The committee continued discussion and recommended referring the review of tenure at two-year institutions back to the Ad Hoc Committee on Tenure, contingent on acceptance from Ad Hoc Committee Chair Ryan. VC Johnson will contact Chair Warford if the Ad Hoc Committee has concerns with continuing their study.

The meeting was adjourned at 10:45 a.m. CT.
