3. Updated FY25 NDUS internal audit plan

Ms. Dina Cashman explained that Core Technology Services is currently updating their disaster recovery plan. Although CTS has a DR plan in place, this project aims to further enhance its effectiveness and provide a more accurate and comprehensive assessment of the DR plan once it is fully established. Given the current state of their DR readiness, conducting an audit at this time would be premature. and the internal audit department would like that audit to be removed from approved 2025 internal audit plan. NDUS internal audit will keep that internal audit as a potential item for future consideration.

Mihalick moved, Ryan seconded, to recommend approval of the updated FY25 Internal Audit Plan, as presented.

Mihalick, Ryan, and Volk voted yes. Motion passed 3 – 0.
