  - Ms. Dolan provided a recap of the week's legislative activity at the SBHE Meeting held on January 30, 2025.
- 3. Preview of Next Week's Legislative Hearings
  - Chris Pieske presented an overview of HB 1365 and HB 1588, which would allow firearm possession on campuses with certain conditions. Vice Chancellor Johnson then briefed SB 2330 which mandates two hours of training on human trafficking prevention for students at higher education institutions during their orientation. Finally, Vice Chancellor Johnson discussed HB 1437 which proposes the prohibition of academic tenure at two-year colleges for new hires after July 1, 2026.
