Call to Order

Committee Chair Volk called the meeting to order at 9:00 a.m. CT.

- 1. Agenda
 - a. Ryan moved, Volk seconded, to approve the agenda, as presented. Approved by consensus.
- 2. Meeting Minutes
 - a. Ryan moved, Volk seconded, to approve the November 13, 2024, meeting minutes, as presented.

3. Updated FY25 Internal Audit Plan

a. Ms. Dina Cashman shared the updated FY25 NDUS Internal Audit Plan requesting approving the change of the engagement for Williston State College. The change would be from advisory services regarding p-card reconciliation process to the audit for TrainND Northwest. An audit has been requested for Williston State College and this has been communicated to President Hirning.

b. Ryan moved, Volk seconded, to approve the audit transfer for Williston State College.

Ryan and Volk voted yes. Motion passed 2-0.

The Executive session adjourned, and the open meeting reconvened at 9:25 a.m. CT.

Discussion Items

- 5. Quarterly (Q2 FY25) Audit Plan Progress Update
 - a. Ms. Cashman shared the regular quarterly update plan progress update for NDUS Internal Audit. Furthermore, Ms. Cashman stated that NDSU's updates were shared to committee members in a separate email on January 22, 2025.
 - i. Member Ryan asked if the Internal Audit Office is comfortable for where they are at with their yearly projection. Ms. Cashman shared that the office is comfortable with finishing the audit plan at this point as shared with committee members.
- 6. NDUS Internal Audit Prior Not Implemented Recommendations Process
 - a. Mr. Dustin Walcker shared that the Prior Not Implemented (PNI) are repeated recommendations that are noted either by the NDUS Internal Audit office from a follow up audit or the State Auditor's office. This process is used to expedite not implemented recommendations.
 - b. The timeline for implementing the PNI recommendations is one year. Each quarter the NDUS Internal Audit office checks the implementation status of the PNI. If the recommendation is 100% implemented, the Internal Audit office will

- verify the implementation status. If the PNI is not implemented, then the Internal Audit office will send an email to the institution management and ask for a status of the recommendations and stress the importance of implementing those recommendations. These are reported to the Audit Committee each quarter.
- c. Member Mihalick asked if this is the best practice for this process as in some cases it takes a year to circle back on those recommendations. Mr. Walcker stated that this would be best practice and moving forward, the Internal Audit office will be asking for the date and time of expected implementation of recommendations when recommendations are in the audits, and they will follow up on those.
- d. Member Ryan asked how often do institutions go beyond one year. Mr. Walcker stated that it is a rare occurrence when this happens as the Internal Audit Office does follow up the following fiscal year.
- 7. Introduction of UND's Senior Internal Auditor
 - a. President Armacost introduced Mr. Tanner Bjerke, UND's Senior Internal Auditor. Mr. Bjerke joined UND at the beginning of January and brings to UND 9 years of experience as an internal auditor in the financial services industry.
