Jerry Rostad, Vice Chancellor of the North Dakota University System, began the listening session at 12:08 p.m. CT.

### Introduction and opening remarks

Opening remarks were provided by President Sanford (BSC), President Armacost (UND), President LaFave (VCSU), President Flanigan (NDSCS), President Steven Smith (Cankdeska Cikana Community College), and Wayde Sick (Career and Technical Education). These remarks emphasized the importance of integrating AI into curricula to meet future workforce needs, discussed AI's impact across industries and the need for investment in AI education and research, and highlighted the crucial role of soft skills in conjunction with technical skills in AI education.

#### **Opening Comments from Energy Industry**

Vice Chancellor Rostad then facilitated a discussion on energy industry perspectives.

Participants included Ron Ness (North Dakota Petroleum Council), Shawn Paschke (Xcel Energy), and Dana Hager (Basin Electric). Key themes emerging from this discussion included the challenges of providing sufficient power for Al data centers, including the high cost of new

power generation; the potential of utilizing North Dakota's natural gas resources for this purpose; and the need for collaboration between energy providers and educational institutions to support AI initiatives.

Vice Chancellor Rostad then led a discussion on data center industry perspectives, with contributions from Terry Effertz (TechND), Troy Walker (Dakota Carrier Network), and Kayla Pulvermacher (MIDCO). Discussion points included the role of data centers in supporting AI and their infrastructure requirements (fiber optics, power, etc.), as well as legislative updates regarding regulations affecting data centers and the importance of a favorable business climate.

# **Opening Comments from Business Innovation Community**

   Tugboat is a portfolio company of Gener8tor ND, 1889, Pathway Ventures and they have participated in the ND Development Fund Angel Match Program.

Vice Chancellor Rostad then introduced a discussion on business innovation community perspectives, with contributions from Todd Pringle (Deere & Co.), Rick Geloff (Bank of ND), and Aaron Mooney (Tugboat). Participants discussed leveraging North Dakota's low-cost energy to attract data centers and AI ventures, emphasizing the need for accessible high-density compute resources to support local initiatives and research, particularly in agriculture and exploration. The Bank of North Dakota's role in financing these projects, including partnerships, was highlighted. Aaron Mooney shared his positive experience with the state's innovation environment, explaining how AI has transformed his business and praising supporting programs and policies.

## **Open Dialogue**

Vice Chancellor Rostad then opened the floor for open dialogue, inviting questions from both in-person and online attendees. The ensuing discussion covered several key areas. Participants raised concerns about power availability and infrastructure for data centers, emphasizing cross-sector collaboration. The group discussed broadening the scope of the interim study on power supply and regulation to include workforce development, Al integration, and university collaboration. The importance of soft skills in graduates was reiterated, along with the need for public education about Al and its applications, including integrating Al education throughout

the educational pathway. Finally, it was noted that BSC is exploring a four-year AI degree focused on training AI technicians for practical application across industries. Tim Mihalick, SBHE Chair, and Dr. Mark Hagerott, NDUS Chancellor, provided closing remarks, expressing appreciation for the participants' time and contributions, and emphasizing the importance of these discussions for future progress.

No action items were considered, and no votes were taken during the listening session.
