

## ND Career Builders Loan Repayment Application

This loan repayment program was established by the 2019 Legislative Assembly under the Skilled Workforce Student Loan Repayment Program (N.D.C.C. 15-10-38.1). The program is designed for business as a tool to recruit and retain talent in high-need and emerging occupations within North Dakota. The program is administered by the North Dakota University System (NDUS).

To be eligible for consideration, applicants must:

- Have successfully completed a qualifying education program.
- Hold a non-defaulted balance on a qualifying student loan.
  - Federal Subsidized, Federal Unsubsidized or Federal Consolidated Student Loans.
  - Federal Perkins Loan
  - Bank of ND DEAL loan, or other private alternative student education loans may be considered. Private loans that are not in the form of a “student loan” will not be considered.
- Not be receiving funding under another state-funded student loan repayment program.
- Reside in the State of North Dakota. Proof of residence will be required prior to each payment.
- Be newly hired (within past 24 months) into a high-need or emerging occupation and work within the State of ND.
- Have qualifying private-sector or other qualifying public matching funds.

Payments under this program will only be made provided that one dollar of qualifying private-sector or other qualifying public funding for each dollar of state funding is available for an applicant. The applicant’s employer or other business/entity must have committed funding prior to an application being approved. Private, public, or federal funds used for the purpose of recruitment or retention of employees may qualify for the match. The matching funds must be received by the NDUS prior to payments being issued.

The maximum amount of loan repayment that an applicant may qualify for under this program is \$17,000, half of which is funded by matching funds.

- No more than \$5,667 per year, or one-third of the applicant’s outstanding student loan principal balance upon application, whichever is less, will be issued. Payments are made over 3 years.
- Payments under this program will be made directly to the loan servicer.
- Applicants who have received funding under the ND Career Builders Scholarship Program will have their eligibility limited to no more than \$17,000 between the loan repayment and scholarship programs.

If approved for the program, applicants agree to provide proof of where they reside, employment verification, and a current student loan document prior to each payment. Additionally, prior to each payment, the matching fund must be received by the NDUS. Payments will be made at least on an annual basis.

- I am not receiving student loan repayment from another ND State program.

- I hold a non-defaulted balance on a qualifying student loan(s) and understand that I must have a non-defaulted balance on the loan(s) at the time of payment to qualify.

**Further, I understand that:**

- I will not qualify for payment unless the NDUS receives qualifying private-sector or other public matching funds.

- My employer will be required to certify my employment prior to each loan repayment.
- The maximum amount of loan repayment that I may qualify for under this program is \$17,000. My annual amount is limited to \$5,667, or one-third of the outstanding student loan principal balance upon application, whichever is less. Payments are made over 3 years.
- My payment will never exceed the outstanding principal balance at the time of payment. If the balance owing on my student loan is less than the anticipated payment under ND Career Builders Loan Repayment program, the payment will be reduced.
- Only qualifying non-defaulted student loan debt will qualify for payment.
- Payments under this program will be made directly to my loan servicer at least on an annual basis.
- I must continue to make student loan payments in accordance with my agreement with my lender. Loan repayment under the ND Career Builders Loan Repayment is a reduction in my principal balance, not a substitute for my monthly required payments.
- If I receive a refund from my lender for a payment made under the ND Career Builders Loan Repayment program, I will return the overpayment to the ND University System. I understand that I am not allowed to retain payments that are beyond your outstanding principal balance.
- Any loan repayment received under this program may be taxable under federal I.R.S. regulations. I will contact my tax preparer for additional guidance.
- I understand that application is not a guarantee of funding.

- I should contact my tax preparer for guidance regarding tax benefits of donating to a state-sponsored program, including a donation made for the benefit of a specific individual.
- Payments will be applied toward the applicant’s outstanding student loan debt over a 3-year period.
- No more than \$5,667 per year, or one-third of the applicant’s outstanding student loan principal balance, whichever is less, not to exceed \$17,000 total, may be awarded under this program. These amounts include both the state and the matching funds. Payments will not exceed outstanding principal balance on the qualifying loan.
- Once funds are remitted to the NDUS for the benefit of the ND Career Builders Program, I may not request a return of funds, and I expect no benefit in return for my donation.
- The NDUS will not issue loan repayment to a lender for student loan repayment until the matching funds are received by the NDUS. I agree to remit payment to NDUS at least annually, or according to the agree-upon schedule. The NDUS will issue an invoice to request the matching funds.
- Prior to each payment being issued by NDUS, verification of employment will be required, in addition to verification of the applicant’s ND residence and submittal of a current loan document. The NDUS will request these items based on the payment schedule.
- Third-party agreements that I may form with the applicant are outside of the ND Career Builders program. Separate agreements should not conflict with ND Career Builders procedures.
- This agreement is in place until revoked by me.
